

Privacy statement Slot Frans & Co. B.V.

Slot Frans & Co. BV (SFCO) processes personal data and other data in accordance with the applicable legislation, the General Data Protection Regulation (GDPR). Your privacy is very important to us, and we handle your personal data with care. Below you will find the pre-conditions

SFCO respects the privacy of all users of its site (www.slotfrans.nl) and ensures that the personal information you provide is treated confidentially. We use your data because you use our services and/or because you provide this data to us yourself. We will only use this information with your permission.

Slot Frans & Co. BV with headquarters at the Burg, Jansenstraat 11, 4431 BK in 's Gravenpolder is responsible for the processing of personal data as shown in this privacy statement.

For what purpose and on what basis we process personal data

SFCO processes your personal data for the following purposes:

- the execution of agreements, transactions, and services.
- relationship management.
- product and service development.
- determining strategy and policy.
- if necessary, detecting unlawful conduct regarding SFCO, its relations and its employees.
- in the context of legal obligations, such as data that we need for our tax return.

Automated decision making

SFCO does not make decisions based on automated processing, but on matters that can have (significant) consequences for people. This concerns decisions that are taken by computer programs or systems, without the involvement of a person (for example an employee of SFCO).

How long do we keep personal data?

Personal data may not be kept for longer than is necessary. The retention period depends on the purpose for which we have received or collected the data and on any legal obligations to retain data. If you have any questions about this, please send an email to info@slotfrans.nl.

Data Security

SFCO takes the protection of your data seriously and takes appropriate measures to prevent any misuse, loss, or unauthorized access, unwanted disclosure, and unauthorized modification. If you have the impression that your data is not properly secured or there are indications of misuse, please send an email to info@slotfrans.nl.

Sharing personal data with third parties

SFCO does not sell your data to third parties and only shares your personal data with business partners and third parties if this is necessary for the execution of the agreement and to comply with any legal obligation. We conclude a processing agreement with companies that process your data, on our behalf to guarantee the same level of security and to monitor the confidentiality of your data. We remain responsible for these processing operations.

View, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by SFCO and you have the right to data portability. This means that you can submit a request to us, so that we can send the personal data we have about you in our system file, to you or another organization mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to info@slotfrans.nl.



To ensure that the request for access has been made by you, we ask you to send a copy of your proof of identity with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.

SFCO would also like to point out that you have the option to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.

Cookies

Cookies, or similar techniques, that we use

SFCO uses cookies through its website. A cookie is a small text file that is stored in the browser of your computer, tablet, or smartphone when you first visit this website.

SFCO uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work properly and to optimize it.

You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information that has previously been stored via the settings of your browser.
